42 MINUTES OF LAST MEETING

**These were agreed to be correct and signed.**

43 MATTERS ARISING

The district officer from the Highways Dept. has passed the request for more road signs along the B4385 to an officer from a different branch of his department, who has not organised a site meeting yet.

44 PLANNING MATTERS

16/04413/FUL Erection of two storey side and rear extension following demolition of Existing single storey extension and provision of 2 parking spaces to front. 7 Chapel Road, Clungunford for Mr Dan Williams. Agreed by parish council planning committee.

16/04680/FUL Conversion of existing barns to 2 dwellings to include some demolition. Barns at Clungunford Farm, Clungunford for Mr & Mrs B & S Rocke. To be discussed by the parish council.

16/04681/OUT Outline application for residential development. Proposed Residential Development west of Clungunford Farm, Clungunford for Mr & Mrs B & S Rocke.

**It was agreed** a site meeting would be necessary in order to make a proper assessment of the Clungunford Farm applications. This to be held on Monday at 2.45.

The inspector's report on the planning application at Heath Farm isn't in yet.

**It was agreed**, that as so few people use the public phone outside the village hall anymore, there was no reason for BT to keep it there. And for the same reason, there was no point in the Parish Council taking over the booth themselves.
