Verges on the roads and corners from the village of Clungunford are becoming dangerous, due to vegetation needing cutting. Highways to be contacted.

The Rocke Cottage corner remains dangerous as visibility around the bend is poor.

There is still a water leak down Chapel Road, Clungunford, which has been reported and an attempt by Severn Trent to resolve the leak has been made. This, however, remains a problem.

Severn Trent are to sink two new bore holes at back of Church View. Cllr Roberts expressed the hope that discussions with senior management about these might lead to work on the problems at the Severn Trent site by Rocke Cottage being commissioned.
